Requirements for attending the BVJ-S (language class)

The BVJ-S is aimed at young people with a migration background who:

- are aged between **16 and 18 years**
- do not have a school-leaving certificate recognized in Germany
- **are still required to attend school** according to German law
- have insufficient knowledge of German.

The goal of this course is the transition to the regular vocational preparation year (BVJ) or the BVJ-E (adult language class).

Requirements for attending the BVJ-E (adult language class)

The BVJ-E is aimed at young people with a migration background who:

- are aged between **18 and 25 years**
- do not have a professional qualification recognized in Germany
- **are no longer required to attend school** according to German law
- have insufficient knowledge of German.

The goal of this course is to prepare students for vocational training or entry into employment.
